# **Smartphone apps for separated co-parents**



Separated co-parents can access a range of smartphone applications (apps) which are designed to support co-parenting communication. Some of these apps are free, while others have an annual fee. Apps usually include a messaging tool, shared calendar, expense tracker, shared documents library, and the ability to export a record of communication between co-parents.

Between 2021 and 2023, Relationships Australia Victoria (RAV) took part in a collaborative research project investigating 9 popular apps used by separated co-parents<sup>1</sup>. One main aim of this research was to help you – as separated co-parents – make an informed choice about whether using an app is right for you.

#### What we did

- Our mediators tested 9 apps by role-playing separated co-parents who were experiencing high conflict and using the apps to complete 5 common communication or organisational tasks.
- We also surveyed app users and a range of family law professionals (e.g. lawyers, mediators).

#### What we found

- On average, our mediators rated all apps 'poor' to 'fair', on a scale ranging from 'terrible' to 'excellent'.
- They generally found messaging features easy to use, while calendar features were harder to use.
- Around half (49%) of all app users surveyed felt that using an app had helped to reduce conflict.

### Should you use a co-parenting app?

Using any co-parenting app will involve potential risks and benefits, which will vary between families. If deciding whether to use a co-parenting app, and/or which app to use, consider your family's circumstances and what your relationship with your co-parent is like.

#### Risks and benefits of apps

Potential benefits	Potential risks					
Accountability: Apps provide a complete record of communication, which may mean communication is more civil and respectful.	If one co-parent is more committed to using an app than the other, or either/both co-parents find it hard to use the technology, it can be a frustrating experience.					
<b>Containment:</b> If there is conflict and/or stress between co-parents, an app can limit this to just one channel of communication.	Apps may replace more direct communication, such as face-to-face or phone conversations which can be healthy for children of cooperative co-parents to see.					
Convenience: Apps which offer multiple functions allow co-parents to keep everything in one place, including messages, a calendar and expense-tracking. This can help to improve organisation and information-sharing between co-parents.	Expense-tracking and record-keeping functions may encourage petty account-keeping (e.g. for financial and/or legal purposes).					
	A shared calendar may set the expectation that co-parents have the right to monitor each other's movements. This can facilitate controlling and/or abusive behaviour.					

## Other questions for separated co-parents to consider

- Why do you want to use a co-parenting app?
- Which app features are most important to you?
- Can both co-parents commit to using an app?
- Does the app need to be free, or can you afford/are you willing to pay for an app?
